To see the lavender we are visiting Provence mid-summer - it will be hot – temperatures can range up to 85deg. This is a trip for active people. Many of the properties we visit are historic and not accessible. This itinerary does not accommodate wheelchairs and due to this being a group itinerary, we are not able to give individual assistance to people with walking difficulties. Please bear all of this in mind when considering this tour. If you have an injury or impairment and are not sure whether this tour is right for you, please contact Kirsty to discuss.
